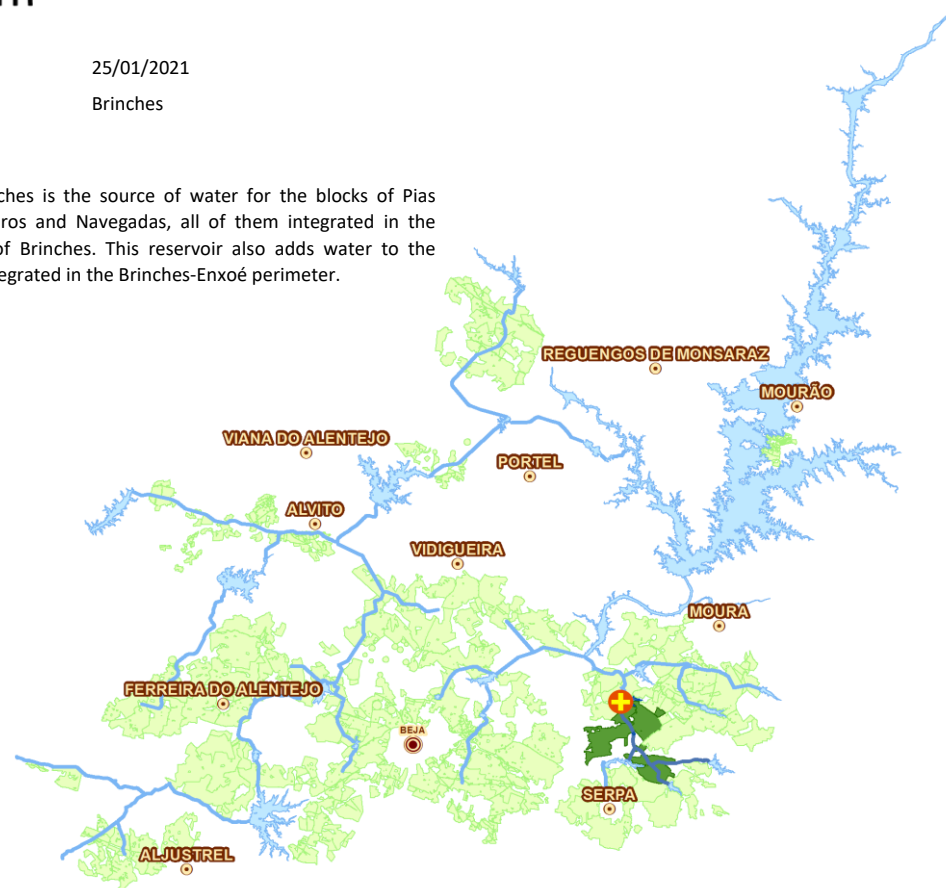

Sampling Place: Brinches

Benefited areas:

The reservoir of Brinches is the source of water for the blocks of Pias Brinches Sul, Cangueiros and Navegadas, all of them integrated in the irrigation perimeter of Brinches. This reservoir also adds water to the Serpa-Pias 1 block, integrated in the Brinches-Enxoé perimeter.



Comments:

The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
