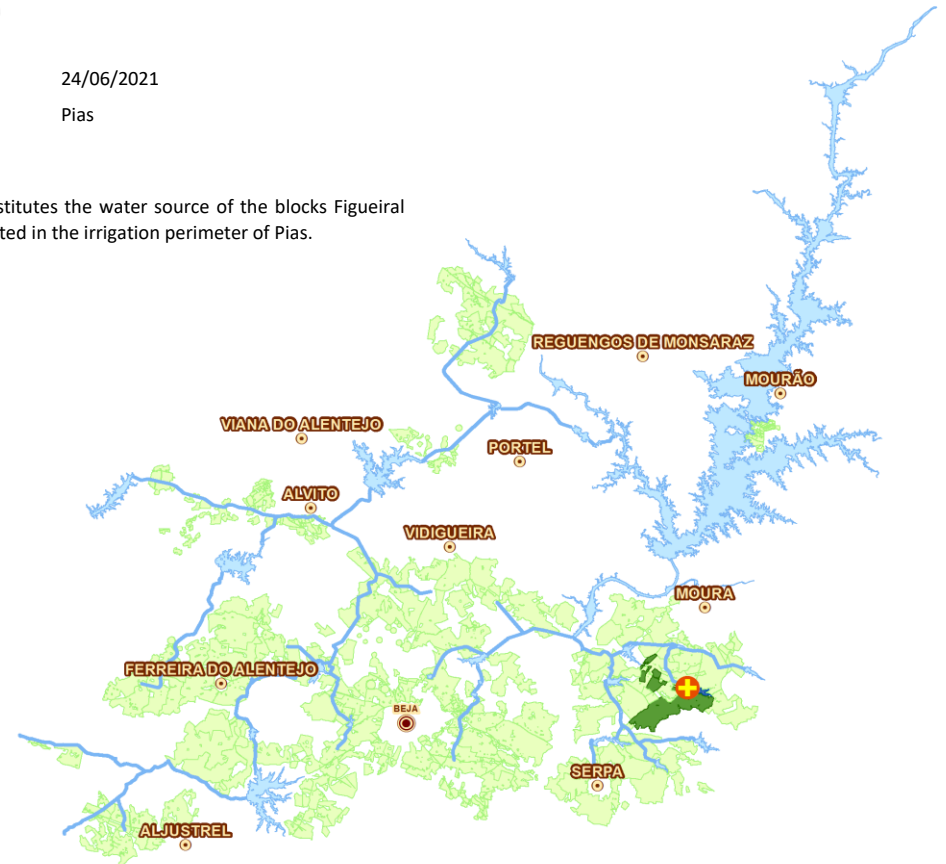

Sampling Place: Pias

Benefited areas:

The reservoir of Pias constitutes the water source of the blocks Figueiral Alto and Pias Alto, integrated in the irrigation perimeter of Pias.



Comments:

Chlorides exceed the VMR for irrigation (70 mg / L) and may originate from natural land drainage or agricultural runoff. At high concentrations they may be toxic to plants and cause deflocculation of soil clays, degrading their structure. The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
