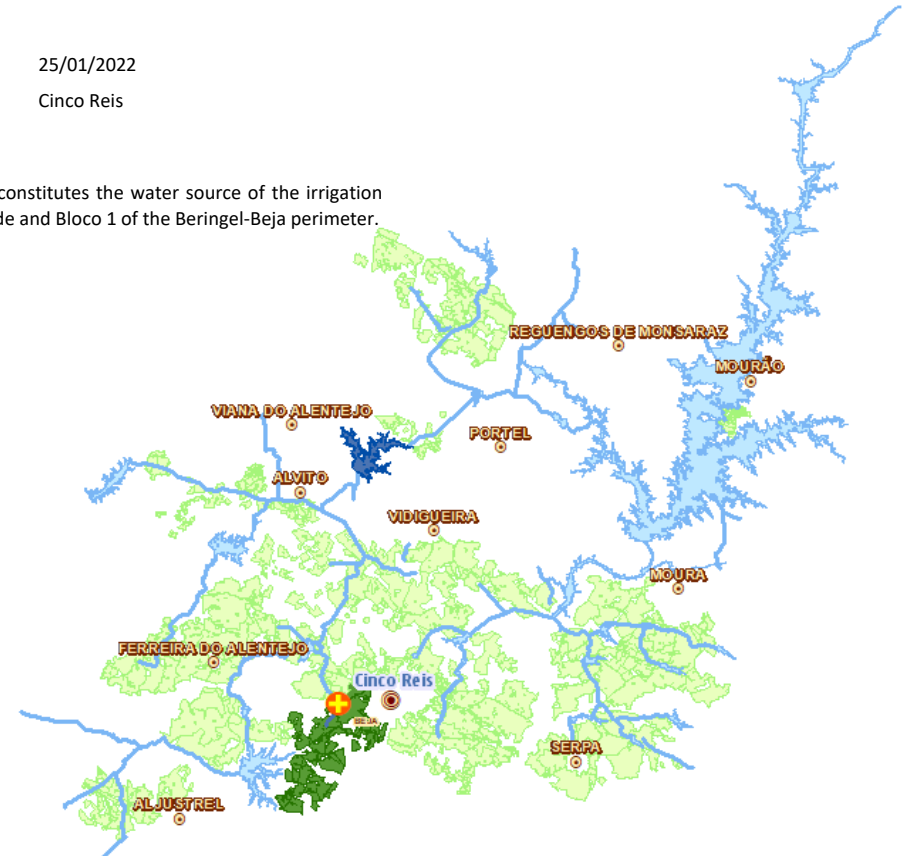

Benefited areas:
 The reservoir of Cinco Reis constitutes the water source of the irrigation perimeter Cinco Reis-Trindade and Bloco 1 of the Beringel-Beja perimeter.



Comments:
 The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
