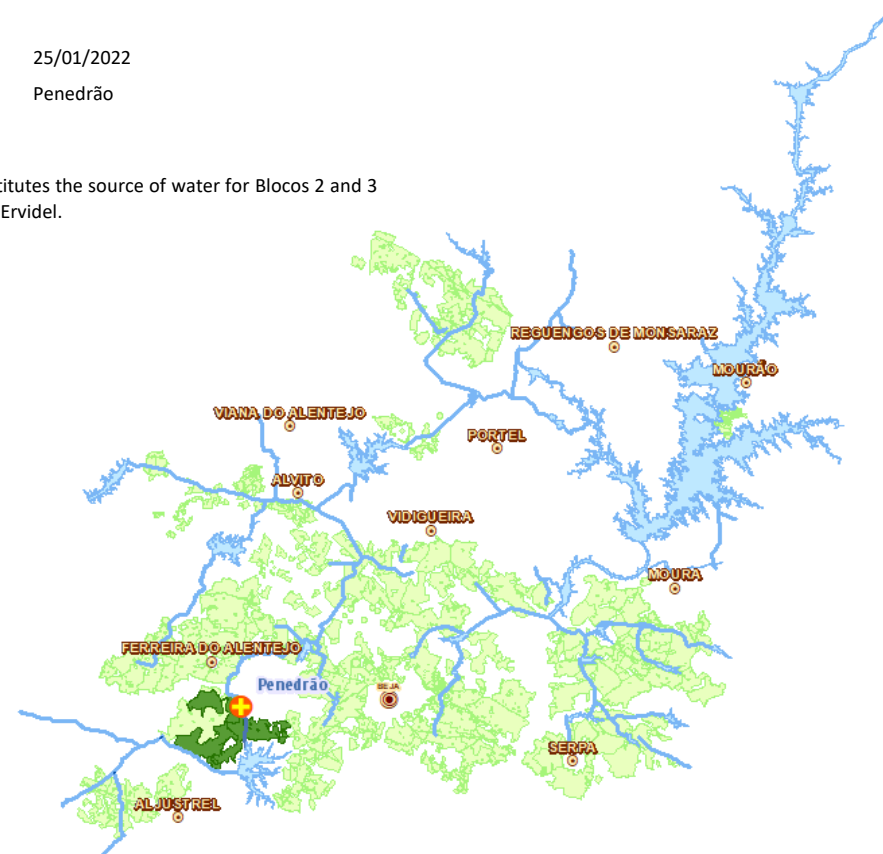
(a) The maximum value recommended in the Integrated Production Standards, for most crops, is 90 mg / L.

**Benefited areas:**

The Penedrão reservoir constitutes the source of water for Blocos 2 and 3 of the irrigation perimeter of Ervidel.



**Comments:**

The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
