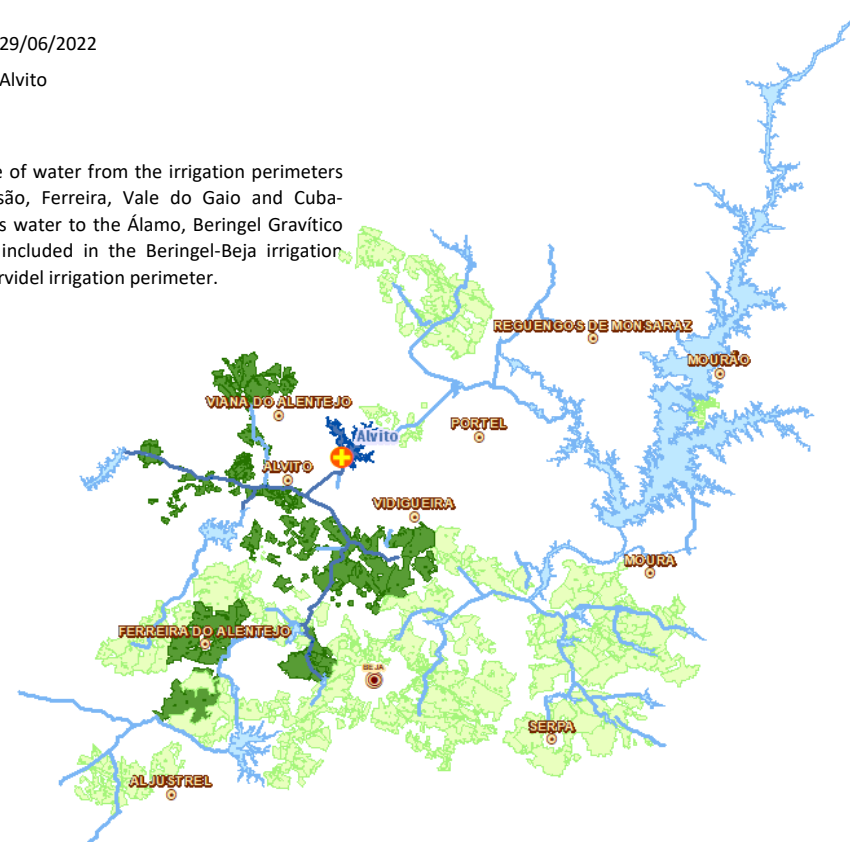

### Benefited areas:

The Alvito reservoir is the source of water from the irrigation perimeters of Viana do Alentejo, Alvito-Pisão, Ferreira, Vale do Gaio and Cuba-Odivelas. This reservoir also adds water to the Álamo, Beringel Gravítico and Beringel Elevatório blocks, included in the Beringel-Beja irrigation perimeter and to Bloco 1 of the Ervidel irrigation perimeter.



### Comments:

The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
