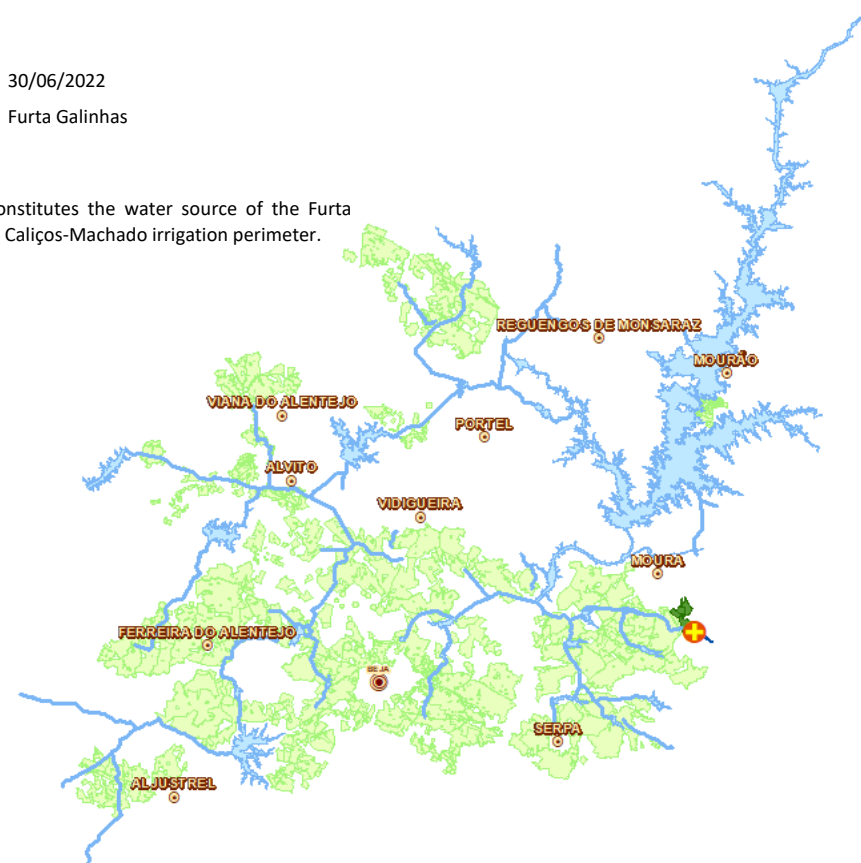

Benefited areas:

The Furta Galinhas reservoir constitutes the water source of the Furta Galinhas block, integrated in the Caliços-Machado irrigation perimeter.



Comments:

The pH result exceeds the Maximum Value Allowed range for water quality for irrigation (VMR: [4,5-9,0]). This may be due to an increase in the biological activity of algae. High pH values can affect the plant's ability to absorb nutrients and promote the precipitation of iron, calcium, magnesium and phosphate ions, which may promote the clogging of drip irrigation systems. The bicarbonate values exceed the maximum value recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the remaining elements are within the range of expected values for this typology of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
