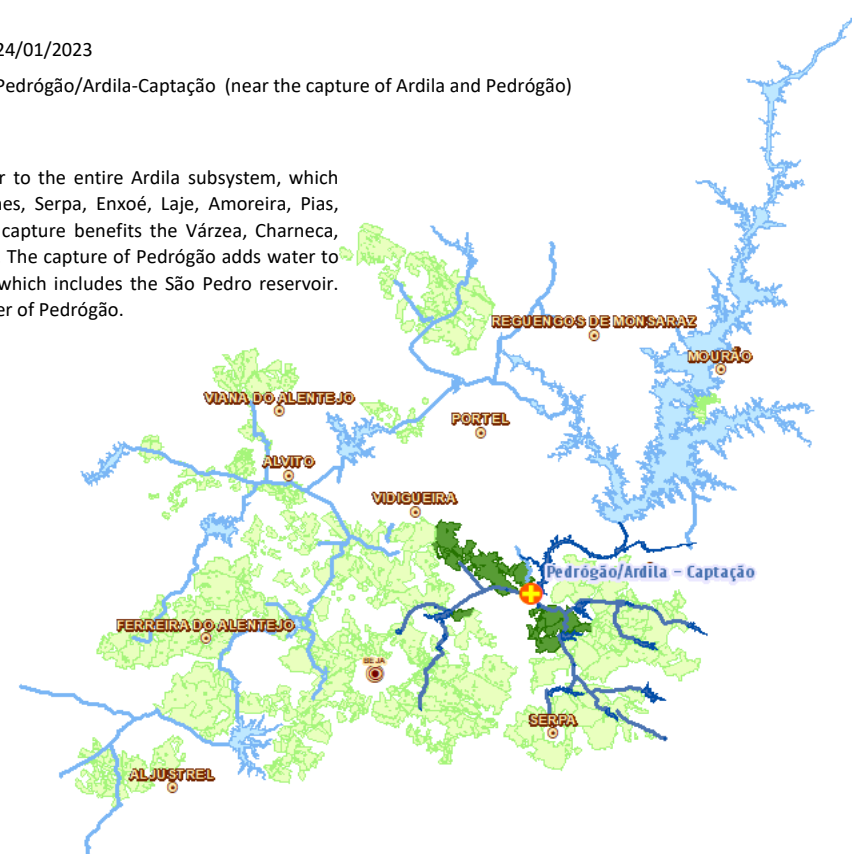

Sampling Place:

Pedrogão/Ardila-Captação (near the capture of Ardila and Pedrogão)

Benefited area:

The capture of Ardila adds water to the entire Ardila subsystem, which includes the reservoirs of Brinches, Serpa, Enxoé, Laje, Amoreira, Pias, Calços and Furta Galinhas. This capture benefits the Várzea, Charneca, Contendinha and Magoito blocks. The capture of Pedrogão adds water to the entire Pedrogão subsystem, which includes the São Pedro reservoir. This capture benefits the perimeter of Pedrogão.



Comments:

The bicarbonates results exceed the maximum recommended in the Integrated Production Standards. High concentrations of bicarbonates can affect crop yields, making it difficult to absorb some mineral nutrients. The results of the other parameters are within the ranges of normal values for this type of water bodies. In the document "Water Quality - Complementary Information", EDIA recommends some general measures to reduce the concentration of salts in the water bodies.
